Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s):

Ch.12 App.7 Art.1.8 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

**Brief Details:**

Nose to tail contact between cars 5 and 25 at turn 8 causing car 25 to Spin. Both drivers were interviewed with their representatives and in car video footage was viewed from car 5.

Accordingly, under NCR Ch.5a App.5 Art.2.3, I hereby order that you receive the following:

Grid Place Penalty to be served at a future race, when that can be applied.  
Number of Licence Penalty Points: 3

Additional Comments: 5 Grid place penalty to be applied to car 5.  
Additional Comments: Version 2 - In accordance with NCR Ch.2 Art.1.23 this decision sheet is reissued to correct a clerical error, that being that the incorrect session was selected.
