Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s):

Ch.12 App.7 Art.1.8 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

**Brief Details:**

Report that car 6 and car 40 had contact. Lap 1 Entrance to Copse during Race 1 Sports 2000.  
Reviewed car 40 on-board footage with driver of car 6. Driver of car 40 was not present. However Driver of Car 40 seen earlier and provided his on board video.  
Footage showed that car 6 was in the middle of three cars approaching Turn 1. Car 40 was on the right inner side of car 6. Car 40 had approached to be in front of car 6 just before the corner, car 6 pulled over to the right, car 40 backed off but car 6 closed the gap very quickly and made contact with car 40 causing car 40 to spin sideways.  
Discussed with the driver of car 6 regarding awareness of surrounding cars.  
I deem car 6 to be responsible for the contact.  
Driver of car 6 was apologetic and said he would apologise to the driver of car 40.  
Decision was advised verbally at 18:19, right of appeal advised.
