Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s):

Ch.12 App.7 Art.1.8 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

## **Brief Details:**

Car 44 was reported as being involved in two possible contact incidents during the final for pick-ups.

Incident 1. Reported as contact with car 30 at Becketts. I reviewed the in car footage and interviewed the driver. He explained his brakes were fading during the race. It can be seen that 30 is alongside and to his right, i.e the outside of the bend. Car 44 can be seen to turn very hard, crossing his arms over and on full lock. Contact occurs in middle of corner, but 30 spins to the inside. On reflection i can see that it was 44's corner and that he made every reasonable attempt to successfully navigate the corner. Therefore, No further action on this incident.

Incident 2. Reported as contact with car 83 at Brooklands. Reviewed the incar footage and spoke again with the driver. He accepted he was at fault and already had apologised to the driver of 83. Again in mitigation he stated that his brake were fading and he was trying to avoid contact but hoped that 83 saw him coming. On reflection, the penalty for causing a collision is mitigated down to formal reprimand only.

In car footage of car 44. Interviewed driver of 44.
