## **Protyre Motorsport: Terms & Conditions of Sale 2025**

As the official tyre service provider the following terms & conditions apply:

#### 1. THE CONTRACT

1.1 These conditions shall apply to any contract to the entire exclusion of any standard terms or conditions specified by the buyer. Acceptance of the products or services by or on behalf of the buyer shall be deemed to be full and unconditional acceptance of these conditions. Payment for all tyres is the responsibility of the person who signs the tyre registration form.

## 2. PAYMENT

- 2.1 Payment for the products or Services must be made in pounds sterling at the event. Failure to do so will result in your tyre supply being suspended until the outstanding balance is settled. The seller shall be entitled to statutory interest and to a fixed sum in respect of any late payment at the rate specified by the Late Payment of Commercial Debts (Interest) Act 1998. Payment on time is of the essence of the contract.
- **2.2** Cash and card payments: will be accepted at the time of purchase & a Proforma invoice will be given at the event. After the race upon our return to the office an invoice will be raised & emailed / posted to the customer. Card payment receipts will not be attached to the invoices.

The customer copy of the card transaction is only available at point of sale due to GDPR regulations.

**2.3** BACS payments: must be received within 5 working days after the event or prior to the event where pre-payment is applicable. Protyre Motorsport must be notified clearly when CHAPS or BACS payments are going to be used. **There must be a reference to the account number, invoice number or the Team/Rider name on each transaction**. Protyre Motorsport bank details are shown in the payment details of this document.

#### 3. GENERAL

- 3.1 A tyre registration form is required for each Team/Rider and must be completed by the person directly responsible for payment. This undertaking is mandatory. Protyre Motorsport must be informed of any changes of circumstances & approve such changes, until then the invoice payer is responsible for all invoices during the 2025 season. Any team/rider who has defaulted on payments in the past, may be asked for payment by card or cash in advance at each event. Full contact details for the invoice payer are required.
- **3.2** Protyre Motorsport must be informed of any changes to the team regarding riders, and an additional rider registration form must be completed in full and signed.
- **3.3** Protyre Motorsport is not responsible for any unauthorised signatures on the Tyre order forms unless Protyre Motorsport is made aware of the specific signatories allowed by the team payer. Please note it is the team payer's responsibility to make Protyre Motorsport aware of the persons who are collecting the tyres.

#### **4 RETURNS**

4.1 Any tyres returned for credit must be returned at the event in which they were purchased.

#### **5. PRE-PAYMENT**

## Official Tyre Supplier

The Manufacturer shall provide to MSVR the standard Supply Agreement that it intends to submit to the Competitors for approval. Both the Contract and any Supply Agreement shall record all terms on which the Tyres are supplied and delivered and shall be identical for all Competitors.

Any exceptions to this rule must have prior written Approval. All tyres must be purchased from Protyre Motorsport for use at the event.

To assist with the smooth running of the tyre racing service we respectfully ask that all teams/riders follow the guidelines below:

- Wheels to be presented clean.
- All detachable spacers & sprockets removed.
- Wheels to be identified by team/rider's number/name & rotation arrow.
- Deflated & presented without valve core/cap.
- Old balance weights removed.
- Old tyres to be marked with identification.
- Old tyres to be taken when wheels collected (if required).
- Old tyres left at the end of the day will be considered as scrap.
- It is the customer's responsibility to collect tyres when removed from rims. We cannot be responsible for tyres left unattended.
- We advise all teams to check tyre rotation is correct upon collection from our Protyre fitment service at the event.

New valve cores will be fitted every time. Please keep hold of valve caps. Protyre Motorsport will supply metal caps when required (always use sealed metal caps and check rubber seal). All tyres will be inflated to 2.0 bar. Pressures must be checked by the team/rider. There will be an additional charge for angled valves. As we are sure you will understand, it will be a very busy time, all help & consideration will be much appreciated, not only by Protyre Motorsport but also fellow competitors by reducing waiting time to a minimum.
